

**Articles Of Incorporation**

**Amended August 7, 2003**

**ARTICLE I:**

The Club shall be a legally organized non-profit entity and shall be known as Loyalhanna United Soccer Club, Inc. (hereafter referred to as The Club).

The area served by The Club consists of Eastern Westmoreland County including Derry and the surrounding communities.

**ARTICLE II: Purpose**

The purpose for which The Club is organized is to provide nonprofit, public, charitable, educational soccer programs and team competition

**ARTICLE III:**

The Club is organized exclusively for charitable and educational purposes under section 501 (c) (3) of the Internal Revenue Code.

No part of the net earnings of The Club shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that The Club shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of The Club shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and The Club shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of this document, The Club shall not carry on any activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of The Club, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose.

**ARTICLE IV:**

The Club shall be affiliated with the United States Soccer Federation through membership/affiliation with the PAWest State Soccer Association. The Club will abide by the articles, by-laws, policies, and requirements of PAWest State Soccer Association and the United States Soccer Federation.

**ARTICLE V: GOVERNMENT**

Loyalhanna United Soccer Club, Inc. shall be governed by its by-laws and mission statement. The Club shall provide charitable and educational soccer programs through its affiliation with PAWest Soccer within the geographic territory as defined in Article I and shall retain its own autonomy

The Club shall be governed by a Board of Directors of not less than four (4) and not greater than seven (7) individuals. The original Board of Directors shall be composed of the organizing individuals. The organizing individuals shall, at the organizational meeting, elect a Board of Directors comprised of two active club coaches and one club member who is a certified referee. The balance of the board may be elected from The Club membership "at-large."

Meetings of the Club shall be held in January, June, August and November of each year and at such other times as the Board deems necessary. Members may request special meetings of the Board. A written request signed by 50% of the active membership of the Club shall be required for a special meeting of the Board.

Decisions of the Board shall constitute operational policy and direction for the Club. Board actions shall be provided to the membership for information only. However, decisions of the Board may be changed by a vote of two thirds (2/3) of the members in attendance at a regularly scheduled Board meeting, or a special meeting, provided however, that a quorum of at least 15 members in good standing are in attendance and voting at the meeting.

The Officers of the Club shall be President, Vice President, Secretary and Treasurer. Election of Officers shall take place every 3 years at the January meeting of the Board of Directors. A nominating committee, appointed by the Board of Directors, shall circulate a slate of nominees no later than two weeks prior to the scheduled January meeting. Nominations from the floor may be taken at the January meeting.

In the event of vacancies in positions on the Board, or among the Officers, the Board shall, by majority vote, fill the vacancy with a member in good standing.

**ARTICLE VI: MEMBERSHIP AND PARTICIPATION**

Membership shall be open to any soccer players, coaches, managers, administrators, and referees in the territory described in Article I. Persons may participate in Club sponsored activities provided said individuals comply with Club and PAWest rules, regulations, by-laws, policies, and requirements. The club will not discriminate against any individual on the basis of race, color, religion, age, sex, or national origin.

**ARTICLE VII: AMENDMENTS**

Any Article or provision hereof may be amended at any regular or special meeting of the membership of the Club provided that the notice of the meeting specifies and sets forth the nature of the proposed amendment and that said notice bears a postmark at least two weeks prior to the declared meeting date.

A two-thirds (2/3) majority of the members present at the meeting is required to amend these Articles and by-law provided however, that a quorum consisting of at least 15 members is present and voting at the meeting.

All proposed amendments must include the present Article or by-law in its entirety followed by the proposed amendment with any new language proposed to be underlined.
